Deadlines

December 8, 2017 - submission of application forms by the Conference attendees.

December 8, 2017 – paper submission. Papers are to be submitted via e-mail in Russian or English.

December 22, 2017 – notification of the Organizing Committee about acceptance of the paper and publishing it in the proceedings. The Conference program includes the papers only in case they are presented by any of the authors, besides students and post-graduates. One participant can present only one paper.

January 19, 2018 – paper submission in the 2nd language. Papers are to be submitted via e-mail.

February 15, 2018 - submission of the Conference proceedings to the publishing house.

The special issue of the Conference materials includes the papers containing actual results of implementation and new developments to address the coal ash handling problem, taking into account the analysis of world experience.
